Dividends & corporate actions



Listed companies sometimes share their profits with you – called dividends. They can also adjust their share structure or can even be taken over by another company – these events are called corporate actions.

Dividends

To receive a dividend, you need to have purchased the shares prior to the ex-date. You can see the ex-date on your dividends plus page (see below).

Dividends+

Check this page to see what dividends or corporate actions are coming up. In the Game, dividends are paid on the ex-date. After completion, all corporate actions that affect your portfolio will be shown on your Transactions page. For additional help please read 'Dividends plus'.

It is extremely important to know that due to limitations of the Game we pay dividends on the ex-date but in the real market this is not how it works. In the real market, to receive a dividend you need to own the shares before the ex-dividend date. You are then paid on the payment date.

Your **Dividends+** page will list all of the dividends and other corporate actions coming up in the Game. These will be shown under 'Upcoming dividends and corporate actions'. If you own a share that is about to pay a dividend it will also be listed at the top of this page in the 'Future payments affecting your portfolio' section.

Transaction history and corporate actions

To see if a corporate action has been paid, you will need to go to your Transactions page - the corporate action will show up in your trading statement

Each corporate action has a code and this code will show on your Transactions page (1) along with a description in the notes section (2).
